- b. Articles of Incorporation to be filed by Byrne Conley with Secretary of State. President and Secretary need to sign four copies. Cost \$30.
- c. Formal letter to Triad to request that CC&Rs be recorded.  
Letter to Triad regarding recording of CC&R restated document – CC&Rs to be signed and Notarized and hand delivered with attachments.

**Resolution #2: The President is authorized to sign the letter transmitting the CC&Rs to Triad Communities, LP for signing and recording once we have received the approved copy of the Articles of Incorporation.**

Motion to approve: Fred Self. Seconded: Pam Hargrove. Passed unanimously.

- d. Hiddenbrooke Architectural Committee (HARC) – Discussion of Triad’s transition and support for HARC. The Restated CC&Rs, Article 6.3 requires that the Board of Directors appoint 3 to 5 persons and one alternate member who may be designed by HARC to act as a substitute on the HARC. Article 6.4 requires there to be staggered terms (three persons serving two year terms and two persons serving one year terms). Appoint 5 with one alternate.

The appointment will be effective upon recording of the CC&Rs and notification from the President that our insurance is effective.**

After the discussion, the board determined that a committee was needed to do more investigation before voting on selecting the Property Management Company. Allen

Wildermuth volunteered to lead the committee. Additional members of the committee are: Jay and Vicki Idlor, Angelo Lamola, Paul Norberg, Joyce Estes and Fred Self. The committee will report back to HPOA within 2 weeks.

The vote on the management company has **been tabled until next month's meeting.**

\$5,941 Annual Premium

D&O and Comprehensive General Liability \$2,000,000;  
\$22,884 Annual Premium

These premiums are based on 1,210 homes as members of the association.

The question was asked whether the general liability could be written to cover selected people rather than for the entire association thereby lowering the cost. Fred Self volunteered to do more research. The decision on insurance has been **tabled until next month's meeting.**
