## **2018/2019 Annual Notice to Members**

After thoughtful review and consideration, the Board of Directors has approved the enclosed budget for the fiscal year ending June 30, 2019, which it believes is reasonable and prudent to meet the funding needs of the Association. The Hiddenbrooke Golf Club has chosen not to renew the Resident Access Program (RAP) and therefore the amenities at the Golf Club will not be available to the HPOA members as part of the assessments. The expense previously paid to Hiddenbrooke Golf Club of the \$55.00 per property will no longer be assessed.

### **MONTHLY ASSESSMENTS**

2018-2019 operating annual assessments are **\$70.00**. The assessment is due on the 1<sup>st</sup> day of July. Your payment must be received by September 30<sup>th</sup> to avoid a late charge of up to **\$7.00 per year**.

The Board of Directors does not anticipate the need to levy a special assessment for planned expenditures. However, the Board reserves the right, in accordance with California Civil Code, to approve a special assessment for unplanned major expenses in the upcoming year.

**Statements are mailed annually. If circumstances should arise that you need to submit a payment and you do not have a payment statement, for example, if you use an online banking service (which means a statement does not accompany your check)** payments can be mailed directly to the bank at:

**To allow processing, the check must clearly indicate the account number and the legal owner's name of record.** If the bank cannot easily detect this information, your payment will be forwarded to the Association for processing. This takes additional mail time and could result in late charges being added to your account.
